How does First Central Credit Union protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files. We maintain physical, electronic, and procedural safeguards that comply with Federal regulations to guard your nonpublic personal information.
How does First Central Credit Union collect my personal information?	We collect your personal information, for example, when you  open an account or apply for a loan  make deposits or withdrawals from your account  make a wire transfer or give us your contact information  We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.]
Why can't I limit all sharing? Definitions	
Affiliates	Companies related by common ownership or control.  They can be financial and nonfinancial companies.  First Central Credit Union does not have any affiliates.
Nonaffiliates	Companies not related by common ownership or control.  They can be financial or nonfinancial companies.  First Central Credit Union does not share with nonaffiliates so they can market to you.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  Our joint marketing partners include investment, insurance, and other financial services companies.
